# **Archives Copy Request Privacy Notice**

Abertay University follows the Information Commissioner's guidelines to comply with data protection legislation, including the Data Protection Acts 1998 and 2018, and the General Data Protection Regulations in respect of the personal information we hold about you. We are committed to safeguarding your privacy and maintaining the security of your personal information. The purpose of this Privacy Notice is to explain to you what personal information we collect and how we may use it.

# What information are we collecting and why?

Abertay University Archives collects the information about you on this form in order to be able to comply with copyright legislation and maintain a record of any items that you have been provided with an image of.

# How will this information be used and shared?

We keep your name and address and note of records that have been digitised in order to have a record of those that have been provided with images from the archive records. It also enables us to trace these records and images in the event that there is any further question about making the images publicly available.

The Archives do not share your personal information with any other organisation or University business area.

# How long we will keep your information for

We will keep this information about you for 3 years from the date of your copy request to us.

#### Your Rights
